**SECTION 4 FIRST AID MEASURES****Description of necessary first aid measures**

Inhalation:	Remove victim from exposure if safe to do so. If rapid recovery does not occur, transport to nearest medical facility for additional treatment. Remove contaminated clothing.
Skin Contact:	If skin or hair contact occurs, remove contaminated clothing and wash skin and hair thoroughly with water and follow by washing with soap if available. Material can be absorbed through skin with resultant toxic effects.
Eye Contact:	If in eyes, hold eyes open, flood with water for at least 15 minutes. If symptoms persist transport to nearest medical facility for additional treatment.
Ingestion:	Immediately rinse mouth with water. Do NOT induce vomiting. Transport to nearest medical facility for additional treatment. If vomiting occurs spontaneously, keep head below hips to prevent aspiration.

**Symptoms caused by exposure**

Inhalation:	Breathing of high vapour concentrations may cause central nervous system depression.
Skin:	May include itching and redness.
Eye:	May include burning and temporary redness.
Ingestion:	Swallowing can result in nausea, vomiting and central nervous system depression.

**Medical attention and special treatment**

Treat symptomatically.

**SECTION 5 FIRE FIGHTING MEASURES**

---

**Suitable extinguishing equipment**

Foam, water spray or fog. Dry chemical powder or carbon dioxide for small fires only. Do not use water in a jet.

**Specific hazards arising from the chemical**

Carbon monoxide may be evolved if incomplete combustion occurs. Will float and can be reignited on surface water. Vapour is heavier than air, can spread along ground and distant ignition is possible. Decomposes on heating emitting toxic fumes, including hydrogen chloride, phosgene and oxides of carbon.

**Special protective equipment and precautions for fire fighters**

Wear full protective clothing and self-contained breathing apparatus. Hazchem code ●3Y.

**SECTION 6 ACCIDENTAL RELEASE MEASURES**

---

**Personal precautions, protective equipment and emergency procedures**

Avoid contact with spilled or released material. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove all sources of ignition in the surrounding area. Take precautionary measure against static discharge. Ensure electrical continuity by bonding and earthing all equipment.

**Environmental precautions**

Use appropriate containment to avoid environmental contamination. Prevent from spreading and entering waterway using sand, earth or other appropriate barriers. Attempt to disperse the vapour or to direct its flow to a safe location for example by using fog sprays. Ventilate contaminated area thoroughly.

**Methods and materials for containment and cleaning up**

For small spills (< 1 drum), transfer by mechanical means to a labelled, sealable container for product recovery or safe disposal. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely.

For larger spills (> 1 drum), transfer by means such as a vacuum truck to a salvage tank for recovery or disposal. Do not flush residues with water. Retain as contaminated waste. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely.

**SECTION 7 HANDLING AND STORAGE**

---

**Precautions for safe handling**

Flammable product. Avoid breathing vapours. Handle and open containers with care in a well-ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Do not eat, drink or smoke in contaminated areas. Electrostatic charges may be generated during transfer. Electrostatic discharge may cause fire. Ensure electrical continuity by earthing all equipment.

**Conditions for safe storage, including any incompatibilities**

Store in a well-ventilated area, away from sunlight, ignition sources and other sources of heat. Do not store near aerosols, strong oxidants and corrosives. Incompatible with amines, alkali metals, nitric acid. Material may react on prolonged contact with aluminium, releasing gas and causing subsequent pressure build up. May react violently with metals such as sodium, potassium and barium, particularly if they are finely divided. May react with freshly galvanised surfaces to produce highly toxic dichloroacetylene. Contact with hot surfaces, sparks or naked flames may generate toxic fumes of phosgene and hydrogen chloride.

**Incompatible materials**

Strong oxidising agents, amines, alkali metals, nitric acid. Material may react on prolonged contact with aluminium, releasing gas and causing subsequent pressure build up.

**Hazardous decomposition products**

Thermal decomposition is highly dependent on conditions. A complex mixture of airborne solids, liquids, gases, including hydrogen chloride, phosgene, carbon monoxide, carbon dioxide and other organic compounds will be evolved when this material undergoes combustion or thermal or oxidative degradation.

**SECTION 11 TOXICOLOGICAL INFORMATION**

Acute toxicity:	Expected to be of low toxicity - LD50 Oral (rat) > 2000mg/kg. If showing signs of central nervous system depression (similar to those of drunkenness) there is a higher likelihood of breathing in vomit and subsequent lung damage
Skin corrosion/irritation:	Expected to be of low toxicity - LD50 Oral (rat) > 2000mg/kg.
Serious eye damage/irritation:	May cause mild irritation to eyes.
Respiratory or skin sensitisation:	Not expected to be a sensitiser.

Carcinogenicity:	Methylene Chloride and Tetrachloroethylene: these materials have been classified by the International Agency for Research on Cancer (IARC) as a Group 2B. Group 2B – The agent is probably carcinogenic to humans.
Reproductive toxicity:	Not expected to impair reproduction.
Specific Target Organ Toxicity (STOT) – single exposure:	Inhalation: Low toxicity - LC50 greater than near-saturated vapour concentration 4 hours, Rat. High concentrations may cause central nervous system depression. Continued inhalation may result in unconsciousness and/or death.
Specific Target Organ Toxicity (STOT) – repeated exposure:	Auditory system: prolonged and repeated exposures to high concentrations have resulted in hearing loss in rats. Solvent abuse and noise interaction in the work environment may cause hearing loss.
Aspiration hazard:	Aspiration into the lungs when swallowed or vomited may cause chemical pneumonitis which can be fatal.
